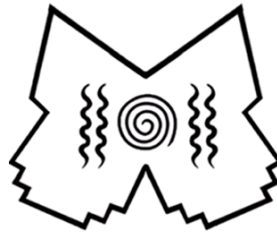

I. COURT FEES

Civil Petition or other first pleading	\$132.00
Domestic Relations Petition	\$137.00
Administrative Appeals	\$117.00
Traffic Citation Hearings	\$75.00
Foreign Judgments	\$117.00
Garnishments	\$117.00
Default Judgments	\$20.00
Appellate Court Appeal	\$100.00

Waiver of Filing Fee: You may be eligible for a waiver of the filing fee if you are unable to pay. Please check with the Court Clerk for waiver eligibility.

NOTE: PURSUANT TO SUBPART D-3 OF THE PUEBLO OF POJOAQUE LAW AND ORDER CODE, TRIBAL OFFICIALS OR TRIBAL REPRESENTATIVES ACTING IN AN OFFICIAL CAPACITY ON BEHALF OF THE PUEBLO ARE EXCLUDED FROM FILING FEES.

Notary Fee (no fee for Pojoaque Tribal Members)	\$5.00

NOTE: SUBPART D-2 OF THE PUEBLO OF POJOAQUE LAW AND ORDER CODE EXEMPTS ATTORNEYS APPOINTED BY LEGAL SERVICES, ATTORNEYS EMPLOYED BY THE PUEBLO OF POJOAQUE, OR LAY ADVOCATES FROM ADMISSION TO PRACTICE FEES.

III. COSTS

Certified Copies of Court Documents \$15.00 plus \$0.50/page
Photocopies of Court Documents \$0.25/page
Copies of CDs or DVDs \$5.00 each
Research and Retrieval Fee \$25.00/hour plus \$0.50/page
Incarceration Costs Assessed to the Defendant upon Conviction

For all proceedings except traffic penalties, the Pueblo of Pojoaque Tribal Court accepts only cashier's checks or money orders for payment of filing fees and costs. The Court will also accept checks drawn upon business accounts for licensing fees and service of process. The Court will accept cash ONLY for the payment of notary fees.
